## 締結姐妹學校協議書

中華民國臺北市信義區吳興國民小學與美國Harvest Christian Academy  
為實現教育的切磋共進，擬定締結姐妹學校，以促進兩校的友好交流與共進發展。

協議內容如下：

### 第一條：目標

兩校師生之間透過相互交流，培養國際觀、理解國際文化和國際市民意識等方面，彼此互相協助，以建立長期合作與交流。

### 第二條：合作領域

兩校本著誠信原則，開展以下五方面的合作與交流。

1. 學生間的聯誼活動
2. 教師間的互訪活動
3. 教育資訊共享
4. 文化體驗與交流
5. 建立其他各相關教育領域的合作體制

### 第三條：協議生效日及有效期

本協議書自雙方學校代表簽字日起生效，有效期為兩年。此外，至協議書期滿日止，若雙方未對協議的內容提出異議，則本協議書自動延長兩年。

### 第四條：附則及其他事項

通過商討確定履行協約具體事宜，當對本協約條例解釋出現分歧時，由雙方協商解決。

## Sister School Agreement

To promote and enrich educational exchange, it is advisable to establish sister school relationships, fostering amicable collaboration and driving mutual development between the two institutions. The agreement encompasses the following terms :

### 1. Objectives :

By facilitating reciprocal exchanges between students and faculty from both institutions, our objective is to nurture international perspectives, enhance understanding of global cultures, and raise international awareness. Through collaborative endeavors, we seek to provide mutual assistance, establishing a foundation for long-term cooperation and sustained exchange.

### 2. Areas of Collaboration :

Collaboration will encompass academic research, joint projects, cultural events, language learning, and other initiatives aimed at enhancing the overall educational experience. The agreement includes the following terms:

1. Joint Organization of Educational Activities for Students
2. Reciprocal Visits of Teaching Staff
3. Educational Information Sharing
4. Cultural Experience and Exchange
5. Establishment of Collaborative Frameworks in Various Educational Domains

### 3. Effective Date and Duration of Agreement :

This agreement comes into effect on the date when representatives from both schools sign it and is valid for a period of two years. It may be automatically extended for an additional year if neither party proposes modifications to the agreement upon its expiration.

### 4. Supplementary Provisions and Other Matters

Specific details of the agreement will be discussed and determined through negotiation. In case of discrepancies in the interpretation of this agreement, the involved parties will resolve them through consultation.
